Directions for Use

Goal 2XL is a selective herbicide for the control/suppression of certain annual broadleaf weeds when applied as a postemergence application to healthy, vigorous Lesquerella. Goal 2XL herbicide can cause necrotic lesions, twisting, stunting or necrosis of the Lesquerella plants.

This SLN is for research purposes and is restricted for use by cooperators in USDA/CSRS project (Agronomic Production Requirements of Lesquerella as a Source of Hydroxy Fatty Acids) - Texas Agr. Expt. Station, New Mexico State University, University of Arizona, Oregon State University and International Flora Technologies, Ltd. **Users of Goal 2XL herbicide acknowledge that a signed waiver of liability is a condition of the registration and the use of Goal 2XL is limited to only those cooperators in the USDA/CSRS project.**

Dosage: Goal 2XL herbicide is recommended for postemergence control at 2 pints (0.5 lb. active) per broadcast acre when applied as a single application to lesquerella that have at least ten true leaves. The occurrence of severe crop injury will increase when applied prior to the crop state listed above.

Method of Application

Goal 2XL herbicide should be applied as a single postemergence spray application when the lesquerella has at least ten (10) true leaves. Goal 2XL herbicide should be thoroughly mixed with clean water at recommended concentration and applied at 20 to 40 psi in 20 to 40 gallons of water per acre.

Weeds Controlled Preemergence

Goal 2XL herbicide will provide postemergence control/suppression of the following weeds when applied at the recommended dosage and leaf stage (2-4 true leaves):

Lambsquarters, Common	<i>Chenopodium album</i>
Lettuce, Prickly (China Lettuce)	<i>Lactuca scariola</i>
Malva	<i>Malva parviflora</i>
Pigweed, Redroot	<i>Amaranthus retroflexus</i>
Shepherdspurse	<i>Capsella retroflexus</i>
Sowthistle	<i>Sonchus oleraceus</i>

Use Restrictions – Goal 2XL Herbicide

The following use restrictions must be observed when Goal 2XL herbicide is used as recommended on this label:

- Follow the General Use Restrictions on the EPA-registered label.
- Read and observe all label directions before using.
- This labeling must be in the possession of the user at the time of application.

- Do not apply Goal 2XL herbicide to lesquerella that has been weakened by disease, nematodes, soil insects or winter injury as severe injury may result.
- **Chemigation:** Do not apply this product through any type of irrigation system.
