Directions for Use:

To control spider mites, apply Brigade 2EC at the rate of 3.9 to 6.4 ounces (0.06 to 0.1 lb. active) per acre. Apply in a minimum of 5 gallons of water per acre by air equipment or in a minimum of 20 gallons of water by ground equipment. When applying by air, 1-2 quarts of emulsified oil may be substituted for 1-2 quarts of water in the finished spray.

Restrictions / Precautions:

The seed conditioner shall keep records of screening disposal for three years from the date of disposal and shall furnish the records to the State forthwith upon request. Disposal records shall consist of documentation from a controlled dump site, incinerator or other equivalent disposal site and shall show the amount of material disposed of, its grower and the date of disposal.
 - b) No portion of the seed alfalfa plant including, but not limited to, green chop, hay, pellets, meal, whole seed and cracked seed, may be used or distributed for food or feed purposes.
 - c) All alfalfa seed conditioned in the State of Arizona shall bear a tag which forbids the use of the seed for human consumption or animal feed.
 - d) No alfalfa seed conditioned in the State of Arizona may be distributed for human consumption or animal feed.
- 2) Violation of any condition listed in subsection (1) of this section is declared a violation of the Use Directions contained in the label and is prohibited.
